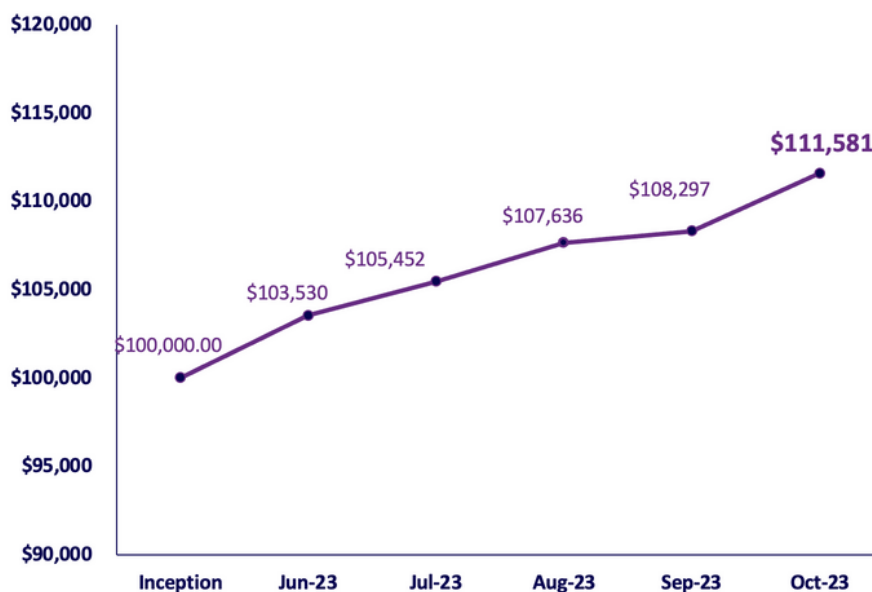

Market Overview

October's markets recoiled under hawkish central bank stances, spurred by robust economic indicators. Simmering Middle Eastern tensions and rising energy prices further unsettled investors, propelling the U.S. 10-year Treasury yield over 5% and triggering a sell-off across both equities and bonds, with global indices and bond yields signaling widespread investor concern.
